

Mount Snow, Vermont

A bus trip sponsored by WPSC – Sunday, Jan 27th to Friday, Feb 1st 2013

Trip Includes:

- Round trip bus transportation from Sewickley, with additional pick-up stops in Meadville and Erie.
- Arrival party with beverages and munchies, included or buffet dinner (Lodge choice).
- Five nights lodging at The Lodge at Mount Snow (www.lodgeatmtsnow.com).
- Monday ski trip to Mt. Stratton
- Remaining four day lift ticket at Mt. Snow (www.mtsnow.com). Skiing until 2 p.m. on Friday.
- Five hot and cold breakfasts, five evening meals with choice of entrée, including a Thursday night choice of fresh New England whole boiled lobster, steak. Vegetarian meals are always available.
- Indoor and outdoor hot tubs
- All taxes and bus driver gratuities are also included. An optional collection for wait and kitchen staff will be accepted on Thursday evening.

Cost:

- **Single - \$800; Double - \$665; Triple - \$645; Quad. - \$625**

As in the past, should you request a double and do not have a roommate, one will be assigned. Should a second person not be available, you will receive a single room, but be charged at the lower cost double rate. Triples and Quads are available on request – not assigned.

Discounts:

- **Non- skier** -- Deduct \$185.00 from the above package for no lift ticket.
- **Senior skier/ boarders** (over 65) – Deduct \$20.00 from listed cost.
- **Bus transportation not required?** – Deduct \$125.00
- **Certificates** – From prizes or late cancelled reservations, must be sent to Charles R. Santi for reduction of trip cost. Certificates are not transferable.

Payments due as follows:

Initial deposit of \$100.00 per person sent with Reservation Form to hold your space; additional payment may be made at any time, but at least 50% is due by **November 15th**, and the remainder due by **January 5th, 2013**.

Cancellations will be charged a \$25.00 cancellation fee. Cancellations after December 15th will result in deposits being charged to our suppliers' terms and any refund may be as a certificate good for a full year for future lodging and food at the Lodge. Changes in lift and schedules after January 5th may not be accommodated and refunds may not be available.

Note that we are limited to 43 rooms, same as last year. The trip will sell out very fast and a wait list will be maintained, but the **initial deposit will be required in order to be placed on the wait list**. Last year we had cancellations in the last 2 weeks and were able to accommodate everyone on the list. Waiting list deposits will be refunded in total should trip be filled.

Western Pennsylvania Ski Council Release Form

Statement of Purpose: The Western Pennsylvania Ski Council provides services such as ski trips and activities as a benefit to member clubs through the participation of volunteer leaders who receive no discounts or compensation for their services. Said leaders are not professionally trained, but undertake the trip/activity leadership to the best of their knowledge and ability and spend many hours during and off-season, organizing, arranging, and leading trips and events.

Release and Waiver of Liability and Indemnity Agreement to the Western Pennsylvania Ski Council

I, the below named individual, being 21 years of age or older, in consideration of services which have or will be performed by the Western PA. Ski Council, in providing travel arrangements and activities and of being permitted to participate in the Council trips, activities, events and other functions which I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) **hereby** release, waive, discharge and covenant not to sue or hold liable the Western PA. Ski Council, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity: and
- (2) **hereby** agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and
- (3) **hereby** assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.

I have read and voluntarily signed the Release and Waiver of Liability and Indemnity Agreement, which shall remain in full legal force and effect until such time that I notify the Western PA Ski Council in writing that this agreement is voided.
