Madonna di Campiglio, is a discreet and elegant town that many consider as Italy's number one ski resort as well as one of the most important resorts in the Alps. The Ski Area has 57 lifts and 150 km of ski runs, with a capacity of more than 31,000 people per hour and is linked up to the nearby ski resorts of Pinzolo, Folgarida and Marilleva. Madonna di Campiglio is also famous for its high life and you will be in the center of it at the four-star Hotel Miramonti. The hotel is situated between two Gondolas and all of the restaurants and nightlife. But with your full, hot breakfast and five course dinners every night, you may not want to eat out too often.

What you get:

- 1) Roundtrip Air from either Cleveland (12 seats) or Pittsburgh (21 seats) to Milan.
- 2) Roundtrip transfers between Milan and Madonna di Campiglio
