**TRIP SPONSORED BY - Western PA Ski Council**

**COST \$950 Land Package (After Oct 15 \$1050) (PIT air, TBA)**

Lodging is at LODGE AT WHITEFISH, 4-day lift ticket for Whitefish Mountain, \$225 less for Non-Skier.

Participants will enjoy a 4-day lift ticket of skiing at Whitefish Mountain with 5<sup>th</sup> day optional, plus 1 day trip to Fernie, BC (must have a passport). (Vert. Drop at Whitefish 2353 Ft, Fernie is 3550 Ft). Over 70 ski free, Discount -\$33, 65 to 69.

### Accommodations:

**Lodge at Whitefish.** Located 3000 feet above sea level on Whitefish Lake. It is about 15 minutes shuttle to Whitefish Mountain Resort. The lodge is only 1 mile from downtown. One can walk to downtown or the Lodge will shuttle.

### Trip includes:

- ◆ Round trip air PITTSBURGH to Kalispel via Delta Air Lines
- ◆ Round trip motorcoach transfer from airport to resort
- ◆ 7 nights accommodation at Lodge at Whitefish and hot breakfast each day
- ◆ 4-day lift pass to Whitefish plus a day to Fernie, BC (**MUST HAVE YOUR PASSPORT**)
- ◆ All Taxes

### Payments due as follows:

1. Initial deposit of \$400 person to reserve space.
2. Second payment of \$600 per person due September 15<sup>th</sup>.

**Western Pennsylvania Ski Council Release Form**

**Release and Waiver of Liability and Indemnity Agreement to the Western PA Ski Council**

I, the below named individual, being 21 years of age or older, in consideration of services which have been or will be performed by the Western PA Ski Council, in providing travel arrangements and activities and of being permitted to participate in the Council trips, activities, events and other functions which I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) **Hereby** release, waive, discharge and covenant not to sue or hold liable the Western PA Ski Council, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity; and
- (2) **Hereby** agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur due to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and
- (3) **Hereby** assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect; and
- (4) **Hereby** acknowledge the agreement of the Carriage of Contact of the airlines.

I have read and voluntarily signed the Release and Waiver of Liability and Indemnity Agreement, which shall remain in full legal force and effect until such time that I notify the Western PA Ski Council in writing that this agreement is voided.
